In exercise of the powers conferred under Article 243-K of the Constitution of India, sub-section (2) of Section 13 and sub-section (2) of Section 14 of the Andhra Pradesh Panchayat Raj Act, 1994 (Act 13 of 1994), the State Election Commission, Andhra Pradesh, hereby, calls upon the registered voters in the Gram Panchayats located in the Revenue Divisions indicated District-wise in Annexure-II appended to this Notification, to elect their respective Ward Members and Sarpanches.
